THE YEAR IN REVIEW






The data collected for the year end 30 June 2024 demonstrates that New Zealand's public libraries are busier than ever, facing increased demand to provide services and resources while operating hours are decreasing. This growing pressure calls for adaptation and innovation to meet the evolving needs of their communities. With over 1.4 million active borrowers—28% of the population—libraries continue to demonstrate their importance as essential public resources.

Over the past year, public libraries recorded 28.6 million physical visits and 30.2 million virtual visits, highlighting their critical role in fostering community engagement.

Operating through a robust network of 315 libraries and 23 mobile units, libraries deliver unparalleled accessibility with a combined 12,863 hours of service each week, a reduction of 74 hours since 2022-23.

New Zealand Public Libraries play a central role in fostering equality. Every public library in the country provides free internet access, ensuring digital inclusion across all communities. In addition to offering printing, scanning, and copying services, library staff are available to assist users and support the development of digital skills. Their strong commitment to inclusivity is evident, with 92% of libraries providing home delivery services for the aging population.



Collection Size & Use

New Zealand libraries are home to an extensive collection of over 9.8 million physical items and 3.7 million e-Items. This equals 9.4 items per active borrower. Borrowing activity has continued to trend upward with 48.4 millions items loaned this year. This includes 15.5 million children's physical items and 8.9 million loans of e-Items, representing 32% and 18% of total borrowing respectively.









Programming

Programming efforts have also expanded significantly, with over 83,000 programmes delivered this year—an increase of 130% since 2017. These initiatives have attracted over 1.5 million attendees, averaging 18 participants per session, and exemplify libraries' commitment to fostering learning and community engagement.



Fine Free Libraries

With a goal of having a Fine Free Aotearoa, as of 30 June 2024, 98% of libraries are fine-free for children's materials, and 78% have eliminated fines for all materials.

Notes

This report presents library data spanning from 2017 to the present. PLNZ is confident that the data from the 2021-22 year through the current period is the most accurate, owing to enhanced data literacy among staff and the implementation of consistent data definitions.

- 1 Data collected starting 2022-23
- 2 The 2022-23 data has been updated and corrected, with social media references removed from the virtual visit information
- 3 For the 2023-24 period, pay-per-use platforms have been excluded from the reported collection size. These platforms were previously included in the 2021-22 and 2022-23 data. The current year's data provides a more accurate representation of the actual collection owned by libraries.
- 4 The removal of pay-per-use (PPU) platforms has led to a decrease in the total collection size per capita. PPU data was not included in the 2020-21 figures, which has resulted in the 2023-24 data being more consistent on a per capita basis.
- 5 In 2023-24, data collected included only e-Magazines, e-Comics and digital movies 2022-23 data included any e-Resources a library subscribed to. With the numerous platforms and reporting metrics, this metric was too variable to include all e-Resources.
- 6 NZLPP New Zealand Libraries Partnership Programme ended 30 June 2022
- 7 Total operating (OPEX) expenditures reported by each council include different types of expenses, so this data should not be used to make direct comparisons between councils

NATIONAL DATA COLLECTION DEFINITIONS

Population

Population at the beginning of the reporting period (1 July 2023) of the library's legal service area.

Number of Libraries

Number of physical locations as of 30 June 2024.

Number of Mobile Service Vehicles

Any vehicle that is a dedicated library vehicle designed to offer library services as of 30 June 2024. Does not include staff or council vehicles used to deliver items to households.

Opening Hours - normal week

The total number of hours when the main services are available to users during a normal week. This includes the main library and branches. If the library is available after hours, unstaffed, by library card access, report these hours also.

Active Borrowers

Number of registered people who have borrowed a physical or digital item within the past 24 months. A digital item is either an e-Item or e-Resource as defined below in Issues (e-Item) and Issues (e-Resource). Active borrowers does not represent the total level of community engagement due to 'hidden membership.' Hidden memberships include people who access the library through other library members (children/couples) who use the same card, or customers who, without registering, visit the library to use materials, computers, Wi-Fi, spaces or attend programmes. These customers will be counted in other stats (visits, computer or Wi-Fi use, programme attendance, etc).

Visits (Physical)

This is the total number of persons entering the library for whatever purpose during the year. If an actual count of visits is unavailable, determine an annual estimate by counting visits during a typical week and multiplying by count by 52. A "typical week" is a time that is neither unusually busy nor unusually slow. Avoid holiday times or days when unusual events are taking place in the community or the library. Choose a week in which the library is open its regular hours. When reporting the physical visits please enter in the note field "Annual estimate."

Visits (Virtual)

The total number of virtual visits to the library managed domains or subdomains, OPAC, and library app, regardless of the number of pages or elements viewed during the reporting period. *From 2019-20 until 2022-23, social media visits were included in Visits (Virtual). Due to the fluctuating ways in which social media is collecting and reporting data and the move away from libraries using social media as they did during COVID, PLNZ has removed social media from Visits (Virtual).

Collection Size (Physical)

Total physical collection size includes all physical library items on hand as of 30 June 2024. This includes all book and non-book material, including but not limited to reference collections, non-circulating materials, magazines, audiobooks, CDs/DVDs, computer games, puzzles, toys, maps, and kits.

Physical Issues - Children and Young Adult

The total number of loans of any physical item, including renewals, of children's and young adult materials.

Physical Issues - Adults

The total number of loans of any physical item, including renewals, of adult materials.

Collection Size (e-Items)

An e-Item is defined as an electronic item that is purchased individually. This includes e-Books and e-Audiobooks. Report the total copies as of 30 June 2024. If you are part of a consortium, report the total number of items your borrowers have access to. If items are purchased as simultaneous use, only report the number of licenses purchased, not issues. Do not include items purchased as a platform, via 'pay per use' agreements or licensed access to electronic resource databases in the collection size.

Issues (e-Items)

Number of loans of e-Items. e-Items are defined as electronic items purchased individually, item or title based, in which statistics can be recorded at an individual item level. Pay per use issues are recorded here.

Issues (e-Resources)

For 2023-24, we are only collecting the issues of e-Magazines, e-Comics, and digital movies, that are not purchased as part of a pay per use model. We are not collecting issues/reads/opens of e-Newspapers.

Programming

The total number of library endorsed programs or events. These are defined as an activity or session that is planned, facilitated, delivered or endorsed by the library or partners in the library, in a community location or online. Library programs do not include events or services delivered by groups that use the library only as a venue. Services are not considered programmes and should not be included here (JP's, reference services, Skinny Jump, etc). An endorsed programme could be a book club held at the library, not facilitated by staff, but advertised by the library.

Attendance at Programmes

Total attendance includes all community members who attended and/or participated in a library program (as defined above) during the year. Do not count staff or volunteers as attendees. For online programmes, this could be engagements or actual attendees depending on the online platform. Report the number that you are confident reporting as attendance and be consistent year to year.

Reading Programme Participants

Report the total number of participants in all offered reading programmes. For the Hell Reading Challenge, count the number of wheels given out.

Home Delivery Service

Any form of home delivery service, including delivery of materials to customers by staff, volunteers or courier.

Number of Maker/Creative Spaces

Total number of permanent maker/creative spaces. Does not include popup type of maker/creative spaces or spaces with portable equipment.

Internet Access

The total number of internet accesses from public devices owned by the library and/or APNK.

Number of Public Devices

Include devices available for public use (desktops, laptops, and tablets). Do not include catalogue only or devices used only for programming.

Staff Numbers (FTE)

Include all paid full time, part time and casual staff that are funded through the library's budget as of 30 June 2024. Calculate the number of FTE (full time equivalent) based on a 40-hour week. Do not include volunteers or vacant positions.

Staff Numbers (actual)

Total number of staff. Include all paid full time, part time and casual staff that are funded through the library's budget as of 30 June. Do not include volunteers or vacant positions.

Funded Staff Hours

Total number of funded hours per week for all staff as of 30 June 2024.

Vacant Staff Positions (FTE)

Total number of funded positions that are vacant as of 30 June 2024 based on a FTE of a 40-hour week.

Staff Expenditure

Total amount of salaries, wages, allowances, training, medical, kiwi saver and other employee benefits paid for the reporting period.

Physical Collection Expenditure

Total amount spent on physical collection including both operational and capital expenditures. This includes processing fees. NOTE: this corresponds to the Physical Collection Size.

e-Item Expenditure

Total amount spent on e-Item collection including both operational and capital expenditures, any platform costs and cost of cost of pay per use items. NOTE: this corresponds to the Issues (e-Items).

e-Resources Expenditure

Total amount spent on e-Resource collections including both operational and capital expenditures and any start-up or platform costs. e-Resources are items purchased as a platform or database. These include the likes of Ancestry, Overdrive and Borrow Box magazines, PressReader, Newsbank, Beamafilm, Storybox, language platforms, library journals and databases. If you cannot purchase individual items within the resource, you would include the expenditure here. NOTE: this does not correspond to Issues (e-Resources) as you would also include any other databases or resources that you purchase as a platform.

Total Operating (OPEX) Expenditure

Total ordinary operating expenditure. This is the actual expenditure spent, less staffing, collections expenditure, depreciation and capital expenditure (CAPEX).
